Introduction

DESCRIPTION:

1. Based on feedback from the field, input from subject matter experts, and correlation with current CDC guidelines this update contains changes to the following COVID-19 reminder dialogs. The version number on all four of these templates has been updated:
 - VA-COVID-19 TELEPHONE FOLLOW-UP
 - VA-COVID-19 PROVIDER FOLLOW-UP
 - VA-COVID-19 DISCHARGE INSTRUCTIONS
 - VA-COVID-19 RETURN TO WORK
2. The alternate dialog text was updates in the COVID-19 screening template to remove the word “they”. The version of the screening templates did not change as this change is not in the dialog text seen by the user completing the COVID-19 screening template.
3. The xml field VA-PPE TYPE used in the provider follow up template has been updated, this field is locally editable so you can add local items if appropriate post install.

Discharge template and instructions in provider screen discharge section – one of these choices is required:

Duration of Isolation and Precautions for Adults with COVID-19

Home isolation can be discontinued based on the following:

- Severe/Critical Illness and/or Severely Immunocompromised
 - 20 days since symptoms first appeared
 - At least 1 day (24 hours) has passed since resolution of fever without the use of fever-reducing medications
 - AND, Symptoms have improved (e.g., cough, shortness of breath)
- Mild/Moderate Illness or Asymptomatic
 - 10 days since symptoms first appeared (or, if asymptomatic, since first positive viral diagnostic test)
 - At least 1 day (24 hours) has passed since resolution of fever without the use of fever-reducing medications
 - AND, Symptoms have improved (e.g., cough, shortness of breath)

Return to Work template – one section only updated – added a new option for severe illness

Health Care Workers/First Responders

- CHRISTMAS,MERRY is a health care worker/first responder with a HIGH or MEDIUM risk exposure to COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder with a LOW risk exposure to COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder and has MILD/MODERATE COVID-19 or suspicious symptoms of COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder and has SEVERE/CRITICAL COVID-19 illness and/or is severely immunocompromised with COVID-19 illness.
- CHRISTMAS,MERRY is a health care worker/first responder and has COVID-19 by lab test without symptoms.

Mild moderate:

CHRISTMAS,MERRY is a health care worker/first responder and has MILD/MODERATE COVID-19 or suspicious symptoms of COVID-19.

Patient may return to work when ALL of the following criteria are met or as per your facility policy:

- It has been at least 10 days since symptoms first appeared (or, if asymptomatic, since their first positive viral diagnostic test)
- At least 24 hours have passed since last fever without the use of fever-reducing medications
- Symptoms (e.g. cough, shortness of breath) have improved

Severe:

Health Care Workers/First Responders

- CHRISTMAS,MERRY is a health care worker/first responder with a HIGH or MEDIUM risk exposure to COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder with a LOW risk exposure to COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder and has MILD/MODERATE COVID-19 or suspicious symptoms of COVID-19.
- CHRISTMAS,MERRY is a health care worker/first responder and has SEVERE/CRITICAL COVID-19 illness and/or is severely immunocompromised with COVID-19 illness.

Patient may return to work when ALL of the following criteria are met or as per your facility policy:

- It has been at least 20 days since symptoms first appeared
- At least 24 hours have passed since last fever without the use of fever-reducing medications
- Symptoms (e.g. cough, shortness of breath) have improved

Telephone follow up note, care disposition section updated, added asymptomatic, updated recovered criteria for improving and stable options:

Indicate patient condition:*

- Patient remains asymptomatic since diagnosis
- Improving
- Stable (neither improving nor worsening)
- Worsening

Indicate patient condition:*

Patient remains asymptomatic since diagnosis Comment:

Patient is Severely Immunocompromised

Patient must meet the below criteria for stopping home isolation.
- It has been at least 20 days since their first positive viral diagnostic test.

Patient has met CDC guidelines for stopping home isolation ("transmission-based precautions") and is released from follow-up.
Patient advised to contact their clinic with future concerns.

Patient is NOT Severely Immunocompromised

Patient must meet the below criteria for stopping home isolation.
- It has been at least 10 days since their first positive viral diagnostic test.

Patient has met CDC guidelines for stopping home isolation ("transmission-based precautions") and is released from follow-up.
Patient advised to contact their clinic with future concerns.

Improving Comment:

Patient with Severe/Critical Illness and/or Severe Immunocompromise

Patient must meet the below criteria for stopping home isolation.
- At least 20 days have passed since symptoms first appeared
AND
- At least 24 hours have passed since last fever without the use of fever-reducing medications
AND
- Symptoms (e.g. cough, shortness of breath) have improved

Patient has met CDC guidelines for stopping home isolation ("transmission-based precautions") and is released from follow-up.
Patient advised to contact their clinic with future concerns.

Patient with Mild to Moderate Illness

Patient must meet the below criteria for stopping home isolation.
- At least 10 days have passed since symptoms first appeared
AND
- At least 24 hours have passed since last fever without the use of fever-reducing medications
AND
- Symptoms (e.g. cough, shortness of breath) have improved

Patient has met CDC guidelines for stopping home isolation ("transmission-based precautions") and is released from follow-up.
Patient advised to contact their clinic with future concerns.

Stable (neither improving nor worsening) Comment:

Patient with Severe/Critical Illness and/or Severe Immunocompromise

Patient must meet the below criteria for stopping home isolation.
- At least 20 days have passed since symptoms first appeared
AND
- At least 24 hours have passed since last fever without the use of fever-reducing medications
AND
- Symptoms (e.g. cough, shortness of breath) have improved

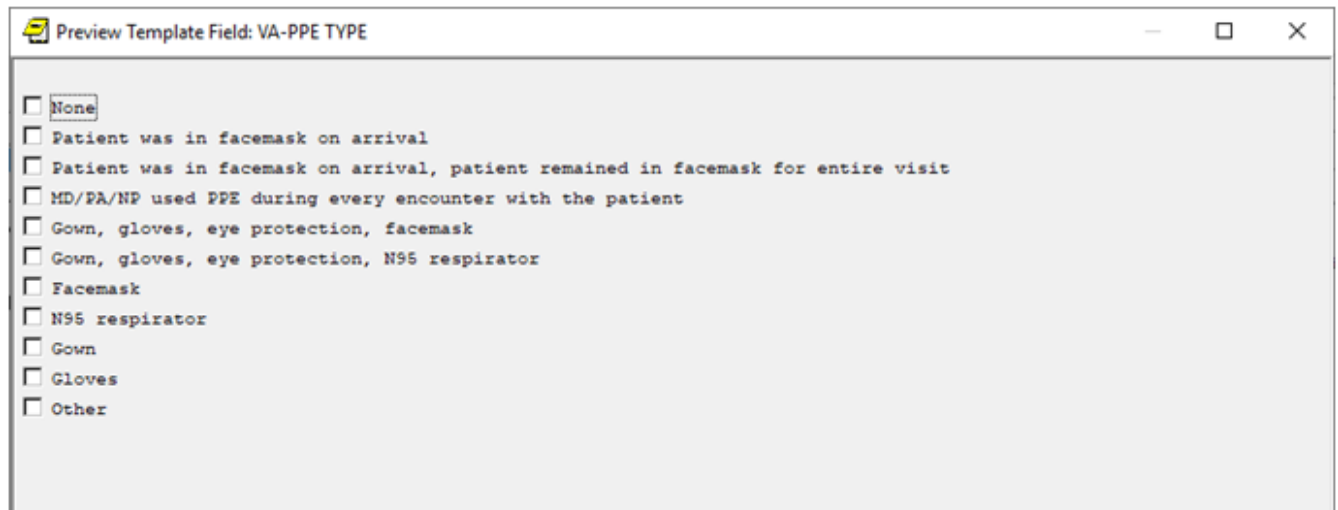

Patient with Mild to Moderate Illness

Patient must meet the below criteria for stopping home isolation.

Alternate progress note text updated in COVID-19 Screening questions used in multiple templates:

Negative screen example:

Coronavirus Disease 2019 (COVID-19) Screen
The patient reports no COVID-19 diagnosis.
The patient reports not waiting for the results of a COVID-19 lab test.
The patient reports no fever.
The patient reports no new or worsening cough or shortness of breath.
The patient reports no cold or flu-like symptoms.
The patient reports no new onset of diarrhea, nausea or vomiting.
The patient reports no new onset of headache, loss of taste or loss of smell.
The patient reports no exposure to someone with COVID-19 within the past 2 weeks.



To Load the Web Host File. Navigate to Reminder exchange in Vista







At the **Select Action** prompt, type **IA** for Install all Components and hit enter.

Select Action: Next Screen// **IA Install all Components**

You will see several prompts, for all new entries you will choose **I to Install**

For this prompt, you will OVERWRITE:

TIU TEMPLATE FIELD entry named VA-PPE TYPE already exists but the packed component is different, what do you want to do?

Select one of the following:

- C Create a new entry by copying to a new name
- O Overwrite the current entry
- U Update
- Q Quit the install
- S Skip, do not install this entry

Enter response: **O//verwrite the current entry**

Are you sure you want to overwrite? N// **Y**

You will be prompted to install the reminder dialog component – You will choose to install all even though some components may have an X to indicate that they exist.

Post Installation

1. **Open the COVID-19 Telephone Follow Up Template and confirm the version is 4.1**
2. **Open the COVID-19 Discharge Template and confirm the version is 3.1**
3. **Open the COVID-19 Provider Screen Template and confirm the version is 3.1**
4. **Open the COVID-19 Return To Work Template and confirm the version is 3.1**
5. **Update txml field VA-PPE TYPE (Optional)**
The txml template field VA-PPE TYPE can be edited using the Edit Template Fields option in CPRS to add additional local items if needed.
