Introduction

Description:

History: The approach to Long COVID Care between VA clinical facilities is inconsistent and was originally designed in isolation of each other. The Long COVID IPT was developed to standardize process for identifying, assessing and treatment of Long COVID. Workstream 2 specifically, is focusing on developing templates, notes, and other tools required to operationalize guidance. The pre-screen template was developed in conjunction with the Long COVID Technical Team to be used to document responses of digital pre-screen sent to veterans identified on the COVID dashboard

Purpose: The Long COVID Pre-Screen template will be used to document responses of the digital pre-screen questions.

This template may also be used as a stand-alone initial contact to assess veteran prior to scheduled appointment as a part of initial screen, phone assessment or other setting.

The template includes the initial plan for follow-up and next steps in the care of the veteran and allows for flexibility in completion of various additional assessments and system review.

In addition to the pre-screen template, there is a new template that can be used to document and send a letter to a patient when you have been unable to reach them.

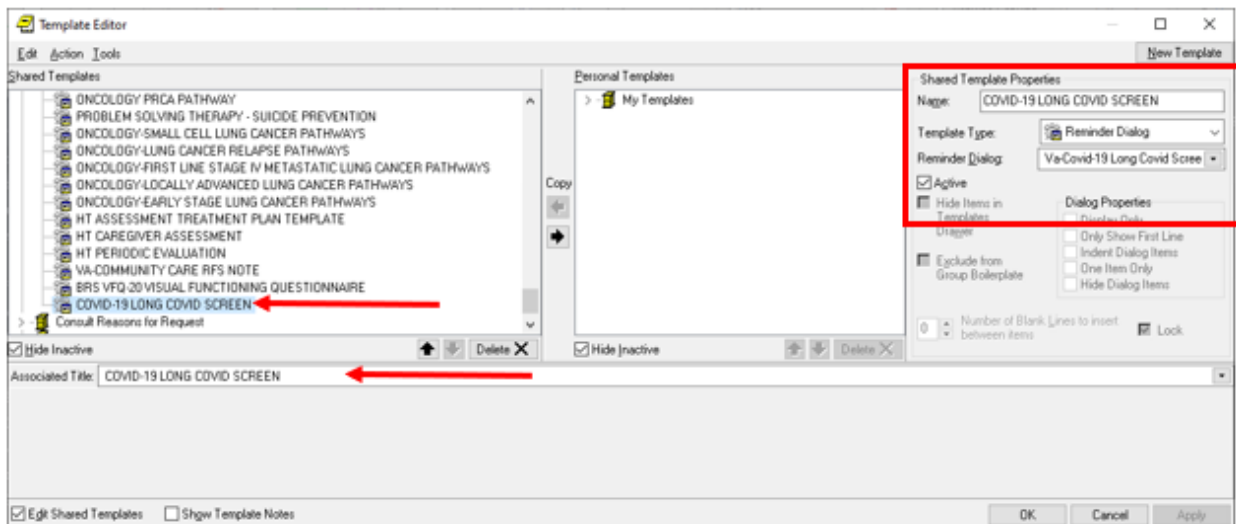

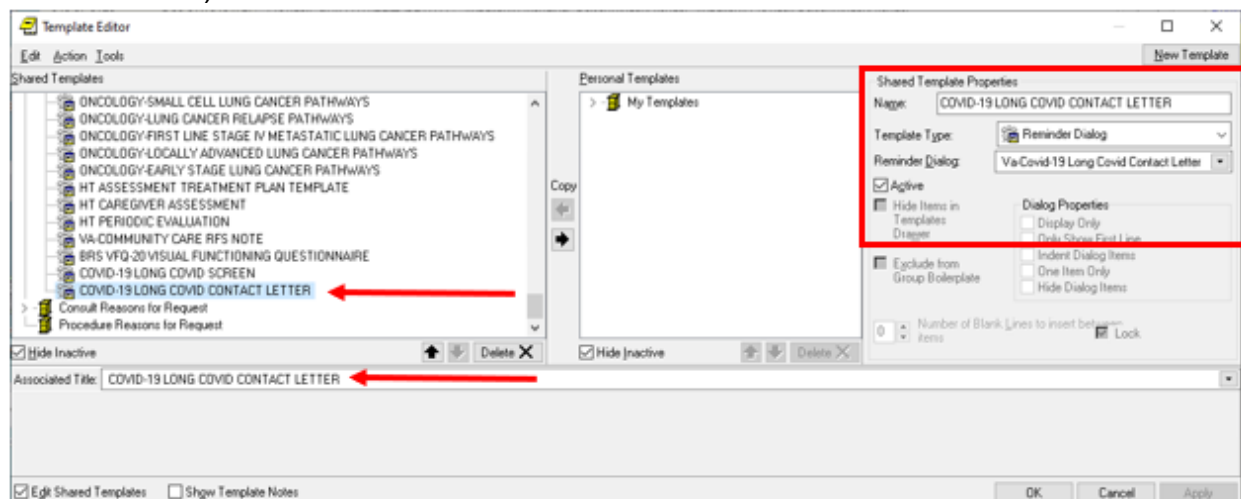
