Introduction

The Under Secretary for Health ensures clinician completion of comprehensive suicide risk evaluations including the discussion and documentation of firearms access and safe storage as required, and monitors compliance. The proposed modifications to the CSRE allows for alignment with Joint Commission requirements and Office of Inspector General required action items for compliance. Additionally, modifications to formatting are to enhance flow of clinical evaluation and documentation for users.

Update	Rationale
Added "Unable to Complete CSRE" section	Allows users to clearly document: Reason CSRE could not be completed Efforts made to attempt completion Risk mitigation plan for acute risk concerns Follow-up plan for CSRE and mental health support, if indicated
Changes to lethal means assessment and risk mitigation	 More clearly differentiates and requires specific assessment and documentation of firearms access vs. other lethal means Risk mitigation now includes space to document lethal means safety counseling for lethal means other than firearm.
Added historical self-harm behaviors with unknown intent	 Ease user review of previously reported potential suicidal behavior by pulling in data about behaviors reported in prior CSREs and SBORs where "unknown" intent was selected.
Suicidal behaviors via overdose section expanded	 Improve risk mitigation by expanding assessment of overdose to clarify if attempt involved opioid and/or stimulants and if naloxone was used to align with Naloxone Memorandum and CSRE overdose OEND sections to align with the SBOR.
Risk mitigation strategies reorganized	 Ease user identification of both general and setting specific risk mitigation strategies by requiring setting selection and including all relevant strategies in that setting's menu. Similar items are also clustered together to improve flow (e.g., acute risk response, environmental considerations, treatment and discharge planning)

- Improve user compliance with submission of indicated HRS-PRF consults to local SPCs by including text describing when a HRS-PRF consult is mandated and requiring a yes or no response.
- Local CACs will be instructed to attach the National HRS-PRF consult to this item.

Opioid Overdose Education and Naloxone Distribution (OEND) section expanded

 Facilitate effective use of OEND strategies via embedded text and links to educational materials to align with Naloxone Memorandum and CSRE overdose OEND sections to align with the SBOR.
